JUDGMENT

By a plaint, the claimant initiated this case and the defendant was able to appear in court today after series of attempts at ensuring his appearance in court and upon appearance today, he admitted the veracity of the claim of the claimant but prayed for time to pay the claimant.

Having admitted the veracity of the claim, the court is left with one singular duty and that is to proceed to enter judgment as claimed by the claimant and same is hereby entered as a matter of course.

I award reliefs 1, 2 and 3 but shall slightly modify relief No. 3 by reducing the interest rate to 5% till the judgment sum is paid. The corollary of the foregoing is that an order sought to be and is hereby granted directing the defendant to pay the sum of N1,429,481.26 being the outstanding balance remaining unpaid by the defendant as at 08/08/2023 on the loan be collected on 10/06/2022 from the claimant.

- (ii) Interest of 7% per month on the said outstanding balance of N1,429,481.26 from 09/08/2023 until the date of judgment in this suit.

- (iii) Interest at the rate of 5% per annum on the judgment debt from the date of judgment until the judgment debt is timeously liquidated.
- (iv) I also award cost of N2,500. I rely on receipt number **NBMQQ-85465** of 15th August, 2023.

JUDGMENT

This is a civil suit between **ARIO FINANCIAL SERVICES & INVESTMENT LTD AND ADEBANJI GRACE YEMI** hereinafter called the claimant and Defendant respectively.

The claimant brought the defendant to court via Default Summons pursuant to ORDER 5 RULES 1 and 6 of the KWARA STATE DISTRICT COURT (CIVIL PROCEDURE) RULES 2022. Whereof the claimant claims against the defendant as follows:

1. The sum of N263,439.89 being the outstanding balance remaining unpaid by the Defendant as at 9th August, 2023, on the loan she collected on 10th of June, 2022 from the claimant.
2. Interest of 7 percent per month on the said outstanding balance of N263,439.89 from 10th August, 2023 until the date of judgment in this suit,

In support of the Default Summons is a 14 paragraphs affidavit deposed to by one Oyewole Olufemi Samuel, the chief executive officer of ARIO FINANCIAL SERVICES & INVESTMENT LTD No. 34, Gaa-Akanbi Road, Ilorin, Kwara State, the claimant in this suit.

Attached to the application are four (4) exhibits which are the copy of the application for loan, offer letter, loan availment form and statement of

account of the defendant with the claimant marked as Exhibits A, B, C and D respectively.

There isn't any notice of intention to defend filed by the defendant and the period within which to defend has since elapsed.

Haven carefully listened to the claimant's counsel in person of Miss D. C. Ebeku while opening their case in this Default Summons proceedings and also after a careful perusal of the Default Summons together with all its attachment thereat, I am comfortable and satisfied with the application to the claimant in the interest of justice.

Hence, the defendant is hereby ordered by this Honourable Court to pay to the claimant the sum of N263,439.89 (Two Hundred and Sixty-Three Thousand, Four Hundred and Thirty-Nine Naira, Eighty-Nine Kobo) being the outstanding balance remaining unpaid by the defendant as at 9th August, 2023 on the loan she collected on the 10th of June, 2022 from the claimant. She must also pay 7% (percent) interest per month on the said outstanding balance of N263,439.89 from 10th August, 2023 until the date of judgment in this suit.

In addition, the defendant is also required to pay an interest of 10% (percent) per annum on the judgment debt from the date of judgment until the judgment debt is finally liquidated. Lastly, the cost of recovery of the loan as agreed by parties must also be paid by the Defendant.

All monies are deemed payable on or before the 31st day of May, 2024.

JUDGMENT

This is a civil suit between Mr. Osiyemi Oladejo Oyeyemi and Mrs. Ojo Oluwakemi Mary and Great Grace Multipurpose Cooperative Society hereinafter called the plaintiff and defendants respectively.

The plaintiff brought the defendants to court via *Default summons* pursuant to Order 5 of the Kwara State District Courts (Civil Procedure) Rules 2022 whereof the Plaintiff claims against the Defendants the sum of One Million Five Hundred and Ninety Thousand Naira (N1,590,000) only being the sum indebted to the plaintiff by the defendants as the sum the plaintiff contributed as savings to the defendants.

In support of the default summons is a 27 paragraph affidavit deposed to by one Osiyemi Bukola the wife of the Plaintiff in this case.

Also attached are 5 Exhibits which are: A copy of the plaintiff's passbook and cooperative payment voucher issued to the plaintiff upon joining the cooperative marked as Exhibit A. A copy of the plaintiff's statement of Account from his bank evidencing how the defendants refunded the sum of N1,710,000 marked as Exhibit B. A copy of the letter of demand dated 18th January, 2023 is marked as Exhibit C. A copy of the letter of discontinuance dated 19th January, 2023 marked as

Exhibit D and also a copy of the letter of reply to the letter of discontinuance dated 7th February, 2023 marked as Exhibit E.

There isn't any notice of intention to defend filed by the defendants and the period within which to defend has since elapsed haven withdrawn the notice of intention to defend/notice of preliminary objection due to irregularity and being out of time.

I have carefully perused the default summons together with all its attachment thereat, I am therefore comfortable and satisfied with the plaintiff's application haven complied with the rules and conditions envisaged for default summons.

Consequently, judgment is hereby given to the plaintiff. Hence, the defendants are hereby ordered by this Honourable Court to pay to the plaintiff the sum of One Million, Five Hundred and Ninety Thousand Naira (N1,590,000.00) only being the sum indebted as the sum the plaintiff contributed as savings to the defendants.
